Dear Parents,

the City of Turin has always valued the present and the future of your children and we know that schooling represents a cornerstone in everyone's life. Therefore, I am pleased to inform you that school will soon begin for 3-year-old children with the opportunity for them to attend nursery schools: whether they are state-owned/state-recognised schools, local or private schools.

Specifically, our city has for years entered into an agreement with the private managers of many private schools. The agreement provides for a contribution aimed at keeping the fees to be paid by families below a maximum threshold agreed between the City and the schools.

Moreover, the relationships built enabled an extensive dialogue both on pedagogical issues and on organisational aspects.

Therefore, this system provides educational services intended for boys and girls aged between 3 and 5, managed by different bodies (the State, the Municipality, through private agreements), yet all committed to building an education system centred around citizens, based on pedagogical projects which promote the relationship of every child with peers and adults, exploration and familiarity with the environment.

*As all schools, while retaining their specific characteristics, are all part of the city education system, and to simplify the enrolment process **for the next school year, all families will be allowed to fill in a single application**, regardless of the school(s) they choose (provided that they are included in the types listed above).*

*Please be informed that, thanks to the existing collaboration with the Local Education Office of Turin and the related school representatives, and given the aforementioned agreements, within the framework of the digitization of the Public Administration, **these services will be available upon online-only registration.***

This method will allow families to save time by providing the opportunity to fill out the application from home without going to specific offices or departments.

SPID - Public Digital Identity System (please visit <https://www.spid.gov.it/> for more information) or **CIE - Electronic Identity Card credentials are required for registration**. These credentials will allow you to access the services of the City and all other Italian Public Administrations.

The specific times and procedures for enrolment and other information relating to the submission of the application for the school year 2025/2026 will be soon available at <http://www.comune.torino.it/servizieducativi/>.
